## Worthy Projects Considered in Grants Cycle

While we have much to be proud of as we survey the list of projects we are able to support with the 2010 Pooled Fund Grants, there is always that tinge of regret that not all the applicants were funded. Some IWCF members may decide to designate their individual grants to these “also-ran” projects or, if they are particularly moved to help a program, give beyond that amount. An inspiring example of the wider impact that IWCF membership has on local philanthropy occurred this spring: after a Friends in Action grant application was not forwarded to the ballot, a member attending that final selection meeting decided to fund the bulk of their request (A/V equipment critical for expanding the Powerful Tools for Caregivers training) through a significant personal donation. It was so gratifying for me to know that even as I delivered disappointing news FIA's very worthy project would be able to go forward.

In recognition of the considerable vetting that each project has received, the Idaho Community Foundation has accepted copies of the proposals that were not funded by IWCF for possible consideration by the numerous donor-directed funds they manage. In addition to those projects that were included on the ballot, two other applications that were endorsed by the 2010 Grants Committee following a site visit will also be forwarded to ICF. # Paola Gianturco speaks in Walla Walla

[One of our members, Tena Lokken, heard Paola speak in Walla Walla, Washington, on May 12<sup>th</sup>. Afterward, she wrote the following to encourage all of us to attend the IWCF Fall Symposium at which Paola is the featured speaker.]

It has been said that many people long to reinvent their lives, but most lack the confidence and creativity to do so. This is clearly not the case with Paola Gianturco and the remarkable women featured in her book, "Women Who Light the Dark." Their stories inspire us to use our time, talents, imagination and other resources to make a difference in our communities and in the world:

- The Girl-Child Network in Zimbabwe - 30,000 girls ages 6-16 who are fiercely dedicated to ending child rape in their country.
- The mothers in Kenya who provided wells near the local schools to ensure that their daughters are able to attend school instead of hauling water as many as seven hours each day.
- The innovative women in Vietnam who begin the healing process for victims of domestic violence by teaching them line dances.
- The creative women in Morocco who create and produce dramatic and entertaining plays that educate illiterate women about their legal rights.

- The resourceful women in India who have educated hundreds of abandoned children on the railway platforms of 12 different train stations.

Paola shared these and many other compelling stories and images from her book, at the YWCA Leadership Luncheon. She spoke to a sold-out crowd of nearly 500 people at this annual fundraiser for the YWCA programs that assist victims of domestic violence and sexual assault. And by supporting this event, the attendees also helped the Global Fund for Women to whom Paola donates 100 percent of her book royalties (and in this case, her speaking fee).

At the completion of her presentation in Walla Walla, Paola said, "My dream about this work is to inspire people to understand each other more completely, so that we can work together more effectively to tackle the problems that darken women's lives, and by doing so, to kindle new hope and possibilities for our world."

We are fortunate indeed that Paola has agreed to be the featured speaker at the IWCF Fall Symposium on October 7th. As she autographed her book for me in Walla Walla, she told me that she is very much looking forward to our event in Boise. So save the date, and start thinking about who you will invite to attend the symposium and be inspired by Paola Gianturco. You will not be disappointed!

# Legacy of Leadership — A Tribute to Outgoing Board Members

As member-at-large for two years, Susan worked on grants, membership and the by-laws committees. Susan has been an ambassador for IWCF, always willing to ably fill a critical need.

**Amy Rustad, Arrangements Chair** - Amy has been arrangements chair since 2007, organizing grants luncheons, annual meetings, the fall symposiums and the Well-Spent Million reception with subtle flair. Amy managed transporting enormous amounts of food and beverage, as well as coordinating with various catering staffs for many functions. Her enormous efforts have resulted in well-organized, professional IWCF events.

**Theresa Fox, Treasurer** - Theresa began her board service as education chair, remained a member while on a two-year sabbatical in Switzerland, then returned to serve as treasurer. Theresa has given IWCF the gift of her professional financial services. Our funds are in impeccable shape, due to her financial background as a CPA and her meticulous work in streamlining our financial procedures and accounting.

**Donna Wetherley, Membership Chair** - As a founding member, Donna has been involved since 2001, at one time serving as both treasurer and membership chairs. Her relentless efforts helped build the membership and retain members. It is difficult to measure the number of membership packets distributed, events organized, e-mails, and phone calls made in Donna's quest to grow IWCF. Our current membership of 245 is a tribute to Donna's efforts.

**Laura White Barton, Member-at-Large** - Laura has served as member-at-large for two years. In that time, Laura has shared her nonprofit experience to help IWCF with some of our critical messaging such as the mural language, the tag line, and our mission statement. Laura has also helped the education committee with its program planning and written communications. One of our most successful fall symposiums featured Laura as our keynote speaker.

## Grants Updates — Highlights of progress reported by 2009 Pooled Grants Grant Recipients

**Idaho Foodbank, Backpack Program: Weekend Nutrition for Children** - By collaborating with school officials, the program increased access to free emergency food for children who depend on free or reduced meals at school. From September through November, 467 children from Ada, Canyon, and Washington counties accessed 3,356 backpacks (equivalent to 20,136 meals).

**Boise Urban Garden School (BUGS), Toward an Edible Schoolyard: W.H. Taft Elementary Garden** - BUGS has been working closely with Taft teachers to design the outdoor classroom space and assist with grade-level curriculum development. Student workshops began in December. Numerous financial and services partnerships joined to complete construction of the garden area. The whole school and greater community participated in a joyful ribbon-cutting ceremony for the Outdoor Learning Center and Community Garden on May 18th.

**The Center for the Arts (Caldwell), Arts Academy** - After a much-delayed and ultimately unsatisfactory mid-term report, the Board determined that we would not release the second half of this 2009 grant. The Center changed or did not fulfill several critical benchmarks for the program outlined in their grants contract. This holdback enabled us to increase this year's Pooled Fund amount by \$12,200 over 2010 member contributions.

**Land Trust of the Treasure Valley, Star River Walk** - It took longer than anticipated to get construction bids for the bridge. Bridge permits are in hand, the bridge contract has been let and it is currently being fabricated. In addition, Star City Council has authorized additional funds to help with signage. Initial design development is underway, with an interpretive planner who has worked around the country on similar projects. Installation is anticipated by June 30th.

**Idaho Voices for Children, First Executive Director Position** - The Executive Director Search Committee took four months to review 130 resumes, request additional personal information from selected individuals, perform interviews and select a candidate. The new ED began full-time employment on February 22, 2010, providing leadership on children's issues throughout Idaho and permitting IVC to take a large step forward towards accomplishing its mission.

**Interfaith Sanctuary Housing Services, Roof Replacement and Shelter Operations** - With operational support, Interfaith Sanctuary was able to add a new staff position to shelter management this summer. The operational funds have been used for leverage in applications for funding from 3 small private foundations. A portion of the roof funds from IWCF will be matched by the Home Partnership Foundation to purchase an additional HVAC unit to move the project closer to completion.
